OPTION 1

You should contact the appropriate devolved combined authority area to secure funding for your study at Reaseheath College prior to starting the course. We have provided you with the information you need to contact your devolved combined authority - click on the relevant weblink listed above.

OPTION 2

You should contact Student Finance at Reaseheath College on 01270 613205 or email studentfinance@reaseheath.ac.uk to request a Learning and Funding Information letter and/or to confirm if a course is eligible for an Advanced Learner Loan. Please note, this option can only apply if you wish to study a Level 3 programme and the course is eligible for an Advanced Learner Loan.
